

2019 UQ CAREERS FAIR – ACCENTURE PROMOTION

Terms and Conditions

- 1 By entering this promotion, you accept these Terms and Conditions.
- 2 Instructions and information on how to enter this promotion form part of these Terms and Conditions.
- 3 The promoter is The University of Queensland (ABN 63 942 912 684) of St Lucia, Queensland, 4072 ("**Promoter**").
- 4 The sponsor is Accenture (ABN 49 096 776 895) of Sydney, New South Wales, 2000 ("**Sponsor**").

Eligible entrants

- 5 To be eligible to enter this promotion, you must be a Queensland resident aged 18 years and over (other than management and employees of the Promoter and their immediate family and anyone else connected to administering this promotion).

How to enter

- 6 Entry will be open from 10:00 AEST on 20/03/2019 and closes at 14:00 AEST on 20/03/2019 ("**Entry Period**"). Entries received outside of the Entry Period will not be accepted.

 - (d) place your entry form in the 2019 UQ Careers Fair Promotion barrel located at UQ Centre (27a) before 14:00 AEST on 20/03/2019; and
- 8 You will receive one entry into the promotion by performing the activities listed in clause 7. You may not enter the promotion more than once.
- 9 All entries become the property of the Promoter.
